

# TICKETING AGREEMENT

This Ticketing Agreement ("Agreement") is made and entered into on this 15 day of March 2025.

## BETWEEN

**Globetex LLC**, having its registered address at 30 N Gould St Ste, Sheridan, WY 82801, USA (hereinafter referred to as the "First Party"),

## AND

**TRAVELOBUDDY LIMITED**, having its registered address at 50 Salisbury Road, Hounslow, England TW4 6JQ (hereinafter referred to as the "Second Party").

### **1. Purpose of Agreement**

This Agreement governs the terms under which the Second Party shall access airline ticketing services, fares, and airline contracts made available through Globetex LLC ticketing systems and platforms.

### **2. Security Deposit & Termination**

In the event of termination, any security deposit shall be held by Globetex LLC for a period of nine (9) to twelve (12) months to cover liabilities including ADMs, chargebacks, disputes, or fraud-related penalties.

### **3. Chargebacks & Credit Card Disputes**

The Second Party shall be fully responsible for all credit card chargebacks or disputed payments initiated by its clients. Payments shall be due immediately upon receipt of supporting documentation.

### **4. Airline Debit Memos**

The Second Party shall be responsible for all airline debit memos related to its ticketing activity and clients.

### **5. Check Payment Terms**

All tickets issued using check payments must be paid in full by the following Tuesday. Weekly check payments shall not exceed USD 5,000.

### **6. Credit Card Documentation**

For all credit card transactions, copies of the credit card (front and back), authorization form, and valid customer ID must be submitted to Globetex LLC.

### **7. Fees**

USD \$10 per ticket issuance, USD \$5 per MCO, and USD \$25 for refunds, exchanges, or reissues.

### **8. System Access**

Globetex LLC shall provide ticketing system access and credentials including access to globetex.us.

### **9. Travel Documentation**

Passengers are solely responsible for possessing valid passports, visas, and travel documents. Passports must be valid for at least six (6) months beyond return date.

### **10. Reservation Names**

Names on tickets must exactly match passport details. Name changes after issuance are not permitted.

## **11. Travel Rules & Restrictions**

All tickets are non-refundable, non-reroutable, and non-changeable after commencement of travel.

## **12. Cancellation & No-Show Policy**

Failure to appear for the first segment results in cancellation of the entire itinerary without refund.

## **13. Disclaimer**

Hidden-city and back-to-back ticketing practices are prohibited and may result in penalties.

## **14. Governing Law & Jurisdiction**

This Agreement shall be governed by and construed in accordance with the laws of the United States of America.

Exclusive jurisdiction shall lie with the courts of the Commonwealth of Virginia, USA.

## **15. Entire Agreement**

This Agreement constitutes the entire understanding between the Parties and supersedes all prior agreements.
